1. Call to Order/Piedges/Prayer

The special meeting was called to order at 6:30 p.m. by Mayor Jana Trew. 4. Financials

5. <u>Texas Municipal League (TML) Intergovernmental Risk Pool</u>

The City Council approved the TML Intergovernmental Risk Pool Worker's Compensation, Property, and Liability Insurance for the Town of Ransom Canyon on a motion made by Councilman Dr. Terry Waldren, seconded by Councilman Ingram Rich; motion carried unanimously.

6. Variance Request for a Hobby Shop

The City Council denied a variance request for a hobby shop located at 55 Parklane on a motion made by Councilman Ingram Rich, seconded by Councilman Dr. Terry Waldren; motion carried with a 3 to 1 vote, with Chip Armstrong voting in favor of the variance. Mayor Pro Tem Brandt Underwood recused himself from the vote.

7. The Building Review Committee

The Building Review Committee met on a September 30, 2019 to discuss a garage addition at 14 Mescalero Drive, and variance for a hobby shop at 55 Parklane. They also discussed the legislative changes regarding building permits.
