1. Call to Order/Prayer

6. <u>Designation of Official Newspaper</u>

Resolution No. 17-000919 designating the Slatonite as the official newspaper for the Town of Ransom Canyon was approved on a motion made by Brandt Underwood, seconded by Jana Trew; motion carried unanimously.

7. Golf Carts

The second reading of ordinance 080817 to authorize the use of golf carts in the Town of Ransom Canyon was approved on a motion made by Dr. Terry Waldren, seconded by Brandt Underwood; motion carried unanimously.

8. Public Hearing on Proposed 2017-2018 Fiscal Year Budget

10. Ordinance No. 17-00210 - Fixing the Tax Levy for 2017

Ordinance No. 17-00210 to approve the effective rate of \$.612933 per \$100.00 valuation was approved on a motion made by Dr. Terry Waldren, seconded by Michael Brooks; a record vote was taken and resulted as follows: Mayor Pro-tem Jana Trew – aye, Brandt Underwood – aye, Michael Brooks – aye, Dr. Terry Waldren – aye.

11. COBRA Continuation of Coverage Administrative Agreement

The COBRA Continuation of Coverage Administrative Agreement with Texas Municipal League MultiState Intergovernmental Employee Benefit Pool (IEBP) was approved on a motion by Dr. Terry Waldren, seconded by Mayor Pro-tem Jana Trew; motion carried unanimously.

12. Section 125 Flexible Spending Arrangement (FSA)

The Section 125 Flexible Spending Arrangement Account with TML MultiState (IEBP) was approved with a maximum level of \$2600.00 in expenses for employees by Mayor Protem Jana Trew, seconded by Dr. Terry Waldren; motion carried unanimously.

13. Independent Contractor Agreement for Librarian Services

15. Resolution to Hire Bojorquez Law Firm, PC, Texas Municipal Lawyers

A resolution to hire Bojorquez Law Firm, PC, Texas Municipal Lawyers to serve as legal counsel for the Town of Ransom Canyon was approved on a motion made by Mayor Pro-tem Jana Trew, seconded by Councilman Brandt Underwood.

16. <u>Memorandum of Understanding between Lubbock County and Town of Ransom Canyon</u>
A memorandum of understanding between Lubbock County and the Town of Ransom Canyon regarding utilizing the city tower to house 9-1-1 equipment for interoperable

communications was approved on a motion made by Dr. Terry Waldren, seconded by Brandt Underwood; motion carried unanimously.

17. Guidelines and Procedures for City Council Meetings

Guidelines and procedures for the city council meetings were approved on a motion made by Councilman Brandt Underwood, seconded by Mayor Pro-tem Jana Trew; motion carried unanimously.

18. Building Committee Report

The Building Review Committee met on August 28, 2017 to approve a request for solar panels at 1 South Lakeshore Drive.

Department Reports

Administration: Elena Quintanilla reported the following:

- She sent a schedule of events to the City Council and asked if any of the Council had questions.
- City hall will be closed on Wednesday at noon, and all day Thursday and Friday in order to move into the new city hall. City hall will reopen on Monday for regular hours.
